Community Garden Summit coming to Kingwood next week

The 10th annual Raising Richland Community Garden Summit will be held Thursday, March 12 from 5-8:30 pm at Kingwood Center, 50 N. Trimble Rd., Mansfield.

This free event will provide inspiration and information for the home gardener as well as those involved in community or organizational gardens.

Summit speakers will include: Jim Chatfield, "Gardening A-Z" from 5:30-6:30 pm, and Malinda Hill "Food Preserving" from 7-8 pm.

Melinda has shared her experience with nutrition, food preservation and family life programming for more than 30 years in Wayne County. She is currently specializing in financial education including; programming for first time homebuyers and other basic money management topics. Hill continues her teaching on food safety with one of her favorite classes, Home Food Preservation.

Jim Chatfield, is the associate professor and extension specialist of The Ohio State University Extension, Department of Horticulture and Crop Sciences, Department

of Plant Pathology. Chatfield has extensive green industry extension workshops throughout the United States, especially in Ohio and the Midwest.

They also include plant problem diagnostics, plant materials, plant selection, and plant pathology topics. Professor Chatfield contributes approximately 75 programs (1-6 hours) per year to commercial green industry and consumer horticulture groups.

The summit will offer fresh produce tasting, garden resources, displays from local community gardens, and garden-themed door prizes. As well as acknowledging the 10th year of Raising Richland with original members and welcome the gardeners of the future.

The Summit also includes a youth program providing hands-on activities for children in grades K-6.

Madison Board looks to move forward with purchase of Lincoln Heights building

Among the many decisions on the Madison Local School Board meeting agenda Feb 26, was the major decision for the board to approve the purchase of the Lincoln Heights property located at 1035 Grace St., in order to move the current Jesse Beer operations to the facility.

Acting superintendent John Thomas recommended the board authorize the treasurer, in her roll as chief financial officer, to execute a purchase agreement for the property between Ohio Heartland Head Start and Madison Local Schools in the amount of \$200,000.

Prior to the board's vote on the issue, operations supervisor Steve Christ shared, "I think all those involved feel that this property has many advantages over the

current Jesse Beer building. It is a better suited location, and the grounds themselves are better. The building has approximately 300K worth of upgrades in roofing, windows and the playground.

In the future all Madison Early Childhood Learning Center operations will move to the new location.

Elisabeth Moss gives a terrific performance in Leigh Whannell's *The Invisible Man*. This is based upon the classic novel and is a continuation of sorts with Universal trying to bring back their classic monsters This was started though with the abysmal *The Mummy* starring Tom Cruise and the future of that was uncertain.

Whannell puts a new spin on the classic story and it makes for one of the more memorable movies so far this year. Moss plays Cecelia, a woman in an abusive relationship with her boyfriend Adrian. After she leaves him and his subsequent suicide, Cecelia thinks her life can finally get back to normal but Adrian is coming after her, and she is not able to see him.

Whannell makes this movie truly suspenseful and scary by making Adrian a central character even though he is never really seen. Moss is so strong as Cecilia that Whannell makes the audience sympathize with her as he lays out clues to help figure out how she can prove Adrian is still alive.

It's interesting to note that Moss's performance is receiving some Oscar buzz. The last couple of years have seen Toni Collette in *Hereditary* and Lupita Nyong'o in *Us* give Oscar worthy performances in the horror genre but this genre has never really broken through to mainstream awards unfortunately. Maybe Moss will breakthrough this year.

The Invisible Man is an absorbing movie from start to finish and very enjoyable even if it does leave open a few questions at times. Definitely check this one out though

as Moss delivers and Whannell, who is no stranger to this genre having driven the *Saw* and *Insidious* franchises, makes a thrilling and fun movie at the same time.

Margaret "Peggy Jo" Carpenter

LEXINGTON: Margaret Josephine "Peggy Jo" Carpenter, 99, went home to the Lord on Thursday, Feb. 27, 2020, just 13 days before what would have been her 100th birthday. She died peacefully in her home at Primrose Retirement Communities, Mansfield, OH.

Peggy Jo was born on March 11, 1920, to Josephine Brockett Ansel and Albert Jacob Ansel in Elgin, Illinois. She graduated from Elgin High School in 1937, and then attended Baldwin-Wallace College (B-W), graduating in 1941 magna cum laude with a Bachelor of Arts degree in German. At B-W, she participated in many theatrical productions, was elected May Queen, and in 1940 was the only woman amongst a group of men enrolled in an aeronautics class that the U.S. Civil Aeronautics Authority sponsored (she was referred to as "the lone eagle"). She successfully completed the course and received her pilot's license.

She married Robert Perry (Bob) Carpenter, her college sweetheart, on Sept. 6, 1943. After Bob returned from completing his military service in the U.S. Army during World War II, they settled in Lexington, Ohio. One of Peggy Jo's first volunteer jobs was serving as a Girl Scout leader; she continued to be a Girl Scout leader for several years and was also an active member of the Lexington Mothers Club.

In 1954, Peggy Jo began her career as an elementary school teacher. Except for two years of teaching in Painesville, Ohio, she taught fourth and sixth grades in Lexington, and she served as an interim principal of one of the elementary schools for a short while. Her colleagues elected her to the position of president of the teachers association. Early in her career, she earned a Bachelor of Science degree in education from Ashland College. Her bubbly personality and love of teaching had an exceptionally positive impact on hundreds of students. After retiring in 1986, she continued to be an active member of the local retired teachers association and Delta Gamma Society, International, an honor society for female educators. She also applied her teaching skills while tutoring children living in the Mansfield area who needed extra help.

As a faithfully dedicated member of the Lexington Presbyterian Church, she was a true "pillar," devoting much time as a choir member, a Sunday School teacher, a women's group member, a deacon, and an elder. In addition, she served for 16 years as the Clerk of the Session. She was also quite involved with the Muskingum Valley Presbytery for several years.

Peggy Jo was enthusiastic, talented, creative, caring, considerate, and loving, as well as extraordinarily dedicated to carrying out the tasks that lay before her. She was a voracious reader who had

many interests. She enjoyed listening to music (was a big fan of classical music and the crooner Perry Como) and watching the TV show "The Big Bang Theory," as well as any TV show featuring the actor Tom Selleck (perhaps because he resembled her late husband!). She was delighted to devour rum raisin ice cream, and chocolate, caramel, and cashew "turtle" candy, and to drink large quantities of black coffee (particularly iced coffee).

Recently reflecting on her life, the deeply religious Peggy Jo remarked, "I've lived a long life and loved the Lord. Now I am going home."

She was preceded in death by her parents; her brother Don, her husband Bob; and her son Scott. She is survived by her daughter Penny Jones and her husband Tom, of Morris Plains, NJ; her daughter-in-law Carolyn Carpenter, of Lexington, OH; her son Lance Carpenter and his wife Deanna, of Frisco, TX. Also, by grandchildren Meg Jones-Monteiro and her husband Filomeno; Anne Weiner and her husband Howard; Christopher Carpenter and his wife Julie; Amy Bowland and her husband Tony; Andy Carpenter and his wife Melissa; Jason Carpenter and his wife Amy; Keely Moulder and her husband Loren, and Faith Carpenter. Also, by great-grandchildren Tomas and Noah Monteiro; Grace and Andrew Weiner; Ben and Makayla Carpenter; Morgan, Chandler, and Emma Bowland; Lacha and Graham Carpenter; Claire and Aiden Moulder. In addition, she is survived by her sister-in-law Irene Ansel, of Dallas, TX.

The family thanks the employees at Primrose Retirement Communities in Mansfield for all of the wonderful care they provided to Peggy Jo during her last years. 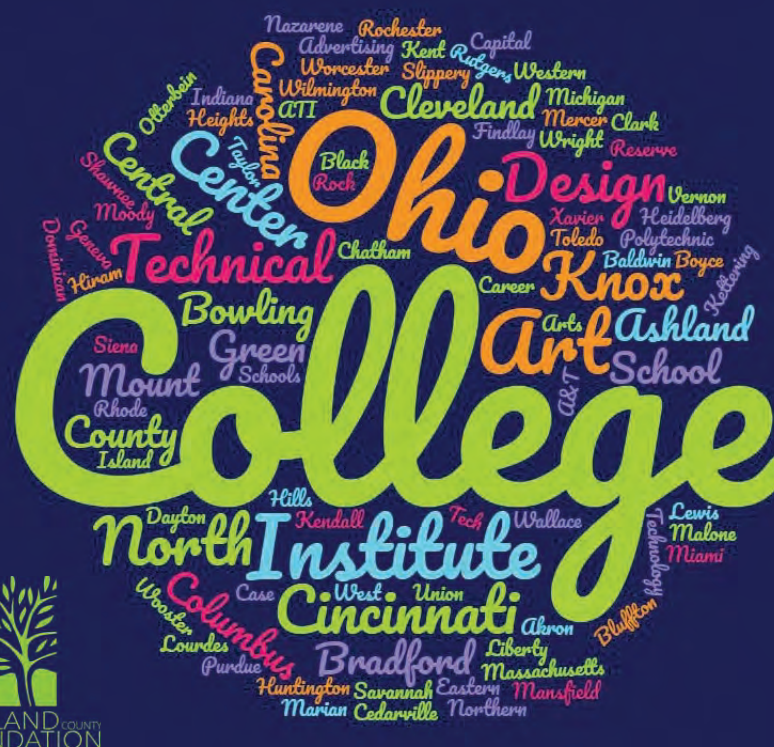

Coburn and Shaver combine for 52 as Warriors outrun Galion

GALION — Tiger sharpshooter Isaiah Alsip dropped a 39 point bombardment on the visiting Warriors, but Shaquan Coburn and Griffin Shaver more than offset the sterling effort as Ontario ran past Galion 80-66 on the final night of January. Alsip made double figures in three of the four quarters, 14 in the first, 12 in the third and 13 in the fourth. But he was blanked in the second canto while OHS piled up 26 in the period to take over the place.

The Tigers blazed out to a 9-0 lead and nudged it up to 14-4 when Alsip scored his tenth point of the joust. That's when Coburn started in, sparking a 12-6 comeback over the ensuing five trips down the court. The Warriors began the next quarter with 11 points on the first four possessions prompting a Galion timeout as OHS had nabbed a 29-27 advantage. Quickly the hosts tallied three on each of the following three plays, then were held scoreless the rest of the half. Ontario tallied the final 13 points of the second frame, with Jayden Price and Ty Namenyi both scoring twice.

The contest was stopped at the 5:50 mark of the third stanza when Alsip nailed his 177th career trey, establishing a new Galion individual record. The Tigers trailed 49-41 at that juncture and Coburn responded by blasting a long shot from out front moments after action resumed. Galion once more ground within eight at 53-45 only to see OHS polish off the period with a 10-3 surge. Jon Nagel swatted a Tiger trey try and raced to the other end when he saw the rejection headed to Shaver. Galion was levied with an intentional foul trying to thwart an anticipated Nagel dunk.

Coburn and Shaver popped in the next ten Warrior markers and Galion never could get the spread under ten again. The Tigers sent OHS to the charity stripe on 7 of the final 8 possessions. Amil Upchurch went there the most often but it was Ryan Brophy who got his club to 80 for the first time this season.

Coburn tied the 2008 team's Jake Mochoskay for the most points scored by an individual Warrior in boys basketball for one game during the 21st century with his 28 point outburst. The last total greater than that was 40 by Benji Hall in a double overtime game at Wynford in 1999. Quan was 5 for 6 on three pointers, 4 for 5 on twos, and 5 for 7 from the line in acquiring his 28 counters. He rejected the Tigers once.

Shaver went 4 for 8 on both deuces and treys and 4 for 7 on foul shots for his 24 markers. He, Nagel and Upchurch all led Ontario on the backboards with five

apiece. Amil was a third Warrior in double digits at 11. Kolten Kurtz picked up coach Joe Balogh's defensive player award. Ty Namenyi again earned the citation for best off the bench outing.

The OHS jayvees were hot in the paint and burned the Tigers 55-39. Gage Weaver was 6 of 11 from the field for his 15 points while Darian Delbrugge tossed in 5 of 8 attempts for his 12 and Alex Rathburn went 5 for 9 in gaining his 11 counters. Zach McCristall cashed all three of his dashes through the lane for six points. Rathburn raked in 10 rebounds and Weaver collared seven. Both Delbrugge and McCristall doled out four assists. Weaver filched the ball four times and Delbrugge stripped it loose thrice. Rathburn hauled off both of coach Tim Henige's awards for defense and off the bench.

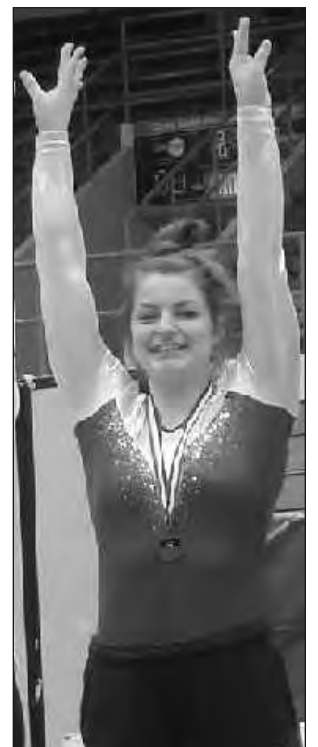
