Lexington makes final approvals as school year prepares to begin

The Lexington Schools Board of Education met Wednesday, Aug. 19, and heard a presentation from Kevin Young and Jeff Eichorn regarding streaming services for athletics and activities.

Lexington High School and WMFD will partner together for WMFDsports.com. This pay-per-view system will help generate "virtual" tickets that will allow spectators to watch live streams of home football, volleyball, soccer and basketball games. This service will also be available on the WMFD App and on OTT Devices such as Roku, Amazon Fire, Apple TV and Android TV.

The board approved the employment of Kelli Catanese, Title I, Central, part time on a one year contact effective Aug. 21; and Laura Boehm, long-term substitute, Western, art, from approximately Aug. 24-Feb. 15, at \$110 per day.

Approved as K-5 mentors to help, monitor and provide the Lexington connection with LDA students at \$20 per hour for up to 15 weekly hours were Margaret Martin, kindergarten; Heiden Eichorn, first; Christina Rose, second; Joy Bowman, third; Barb Durchik, fourth; and Michelle Lillo, fifth.

Employment was approved for Laura Boehm, sub calling at Western Elementary for the 2020-'21 school year; Lisa McClain, food service substitute; Geoffrey Newland,

substitute educational aide; and Scott Hamilton, athletic department assistance at \$15 per hour.

Tuition students for the 2020-'21 school year are Vincent Morando, continuing grade 12; Celia Connell, new, grade 12; and Kellen Young, new, grade 11.

Alyssa Hostetler was hired as a junior high cross country coach. She was previously approved as a volunteer assistant.

Jim Steele was approved as a volunteer assistant for junior high football.

The board voted to increase lunch prices for the 2020-'21 school year by 10 cents per lunch. The prices will be \$2.85 for elementary, \$3.10 for junior high students, \$3.35 for high school students and \$4.05 for adult lunches.

The agreement and Memorandum of Understanding with Ohio Heartland Head Start for the 2020-'21 school year was approved as was a contract with Mid-Ohio ESC for the district to utilize Mid-Ohio ESC's SPARC funds of \$2,404.91 for career coach costs.

A revised substitute list, dated July 15, as presented by MOESC was accepted.

Nurses hired, pending successful completion of all pre-employment requirements, were Jennifer Sexton, Eastern Elementary; and Brittany Gist, high school/junior high.

Richland County Parkinson's Support Group named 2020 Community Service Awardee

The Ohio District 5 Area Agency on Aging Inc. selected the Richland County Parkinson's Support Group as the 2020 Community Service Awardee. Nominated for the groups ongoing support and encouragement, the group was recognized with an outdoor ceremony at Hawkins Corner in Ontario on Wednesday, Aug. 19.

Those attending remained in their cars and celebrated with honking horns and flashing lights.

The Richland County Parkinson Support Group meets on the third Wednesday afternoon of each month at the Waterford Retirement Center, 1296 S. Trimble Rd., Mansfield. They welcome people from Richland and other counties. To reach out to new members, the group mails postcards, posts meeting notices at the Mansfield YMCA and sends yearly calendars to Ohio Health MedCentral's Physical Therapy Department and to Delay the Disease. The group is also listed on the Parkinson's Foundation Great Lakes website.

"We encourage people to bring their caregivers, and other family members with them to the meeting," said Becky Roggio of the Richland County Parkinson's

Support Group. "We do not want Parkinson's to be a dreaded disease, but rather an opportunity to learn about the disease and be proactive in managing it, because every day is a Gift."

"Every meeting begins with a short session of exercise led by Amber, who is a member of the Delay the Disease staff from Ohio Health. We know that exercise is like medication in helping with tremors and reducing rigidity. We encourage our members to go to Delay the Disease classes and to the local YMCA regularly," said Roggio.

"Guest speakers have Parkinson's specific subjects such as new medications, clinical trials or new treatment options available. Special guests also have included the Clear Fork Show Choir and interactive games are sometimes incorporated."

"My own mother had Parkinson's in a small town in Penna, and she had no Parkinson's support group available to help her manage her disease. I want the people of Richland County and surrounding areas to know there is support and help for Parkinson's Disease," said Roggio.

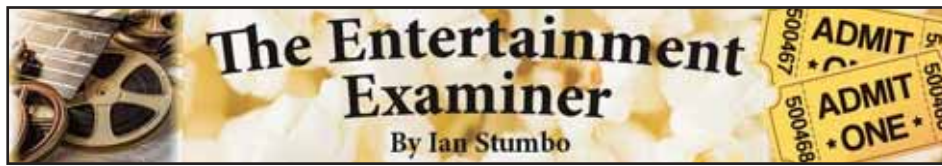

Instead of reviewing a movie this week, I decided to review a new album by a classic rock band that is definitely worth listening to. Deep Purple have been playing great music since the late 1960s and their new album *Whoosh* is certainly something that is worth checking out.

Deep Purple has had a stable lineup for a while consisting of Ian Gillan on vocals, Roger Glover on bass, Ian Paice on drums, Don Airey on keyboards and Steve Morse on guitar. Produced by the legendary Bob Ezrin, who has produced the last couple Purple albums and also produced albums by Alice Cooper and Kiss in his long career, Purple and Ezrin give an album where every song sounds unique while still retaining that classic sound that propelled "Smoke on the Water" to its iconic status.

The best songs on the album are certainly the opener "Throw My Bones" and the epic "Man Alive" which even has spoken word moments by Gillan. Other worthwhile tracks are the ballad "Nothing at All", "No Need to Shout", the 60s vibe



on "What the What" and the very interesting "Step by Step."

Deep Purple has had this lineup for a long time and what a great lineup this is. While many miss the legendary Richie Blackmore on guitar and that is completely understandable, Steve Morse is a brilliant guitarist in his own right and has fit in to the guitar spot since 1993.

Deep Purple with Morse has made some terrific albums and if you only know their material with Blackmore, their output in the last couple decades has also been terrific and absolutely worth checking out.

Whoosh is a great new album in this legendary band's catalog and while a couple instrumental tracks are slightly passible, this is one to check out and hear how Deep Purple is still relevant and great after all these years.

Richland juvenile detention facility now serves neighboring counties

Under the direction of Judge Steve McKinley, the Richland County Juvenile Detention Facility is providing much needed assistance to troubled youth beyond the borders of Richland County.

The local detention facility, through agreements between local juvenile court judges and boards of county commissioners, also serves the detention needs of Ashland, Crawford, Holmes, Knox, Marion, and Morrow counties.

"My staff and I are pleased to assist our neighboring counties, many of which do not have a juvenile detention facility of their own.

"The revenues arising out of the agreements with these counties also helps to defray the cost of operating our facility, a financial benefit for Richland County citizens.

In 2019, we generated \$196,800 in rev-

enue that supports the general fund," said Judge McKinley.

The 25 bed facility provides a safe, secure, and rehabilitative environment for youth determined to be of potential risk to the community or themselves. Detained youth are given around-the-clock supervision, while employing the least restrictive methods to serve the best interest of each child. Daily programming includes year-round educational classes by certified teachers, physical fitness activities, life skills training and various other activities.

As the father of six children, Judge McKinley has a passion for helping at-risk youth, and understands the need for both nurture and accountability. McKinley goes on to say, "The work of Juvenile Court helps these youth within the context of ensuring that our community is kept safe."

John Williams dug his own grave

John Williams was a hard working, multitasker and talented man. He worked at the Cockley Mill, was a house painter and was known for his stone and concrete work. He laid some of the early stone slab sidewalks in Lexington. One of his first jobs was laying the walks near the town square for the heavy foot traffic in the busy downtown. He also worked at times in the Lexington Cemetery and had a matched team of horses to pull a hearse for the funeral home.

He had served in the Civil War and his duties took him to Tennessee, Mississippi and Alabama where he was sometimes or-

dered to carry the wounded from the battle field and work as a nurse in field hospitals, one of which was a smallpox hospital.

He had witnessed death and human misery beyond imagination. That's why townsfolk began to watch as he dug a grave, a much, much larger grave than normal at the graveyard, enough for two people.

The thought ran through some people's minds that what he had experienced during the war had effected him and he was contemplating a murder-suicide. He and his second wife seemed to be getting along or so they thought.

First came the concrete floor, followed



by stone slab and concrete walls with a stone slab dividing the grave into two parts. When asked about it he simply said that it was "to keep me and the old woman from fighting." It was all just an attempt to create more jobs.

Eighty year old Elizabeth Williams dies in 1915 of natural causes. John followed her five years later, the only man to ever dig his own grave.

Flag will be raised in honor of veterans

Richland County Joint Veterans Council announced the Honored Flag would be raised on Thursday, Sept. 3, at 6 pm, in front of the Richland County Courthouse to honor deceased Richland County brothers U.S. Army Veterans Burton R. Claypool and Leonard B. Claypool.

Burton Claypoole was born May 16, 1923 in Newville, WV, to Jesse and Dulcia (Morrison) Claypool and passed away Sept. 2 at the age of 92 and was buried in the Bellville Cemetery.

Burton served his county during WWII, joining the U.S. Army on Feb 13, 1943, until Dec. 20, 1945. He served in Normandy, Northern France, Rhineland and Central Europe.

He was a member of the Bellville AMVETS 43, V.F.W 9825 and American Legion 535. He worked for the Richland County Road Department for 30 years, retiring in 1988.

He is survived by three children, Linda Doty, JoAnn Rhodehouse and Burton B. Claypool, grandchildren and great grandchildren. He is preceded in death by his wife, Norma Jean Goss Claypool.

Leonard B. Claypool was born Oct. 16, 1921 in Palmer, WV to Jesse and Dulcia (Morrison) Claypool and passed away Nov. 3, 2016 at the age of 95 and buried in Oak Grove Cemetery.

Leonard served his county during WWII, joining the U.S. Army on July 16, 1942, until Jan. 13, 1946.

He was a member of First English Lutheran Church and was employed with Westinghouse retiring after 40 years. He is survived by his wife Betty (Hassinger) Claypool; three daughters Sharon Nevius, Susan Fife and Rebecca (John) Roe, seven grandchildren and numerous great grandchildren.

The Honored Veteran's Flag will be flown for 21 days at the Richland County Administration Building after which the veterans' names will be engraved on a brass name plate and added to a plaque listing those veteran's honored in the same manner already displayed on the wall in the foyer of the Richland County Administration Building. The Joint Veterans Council of Richland County operates the flag program.

GOP ONTARIO RALLY — A group of local citizens and public officials gathered at PR Machine Works in Ontario to attend a local GOP Rally on Aug. 19. Guest speakers were State Representative Mark Romanchuk who is running for State Senate, Ohio Senate President Larry Obhof, State Representative Darrell Kick and Richland County Commissioner Marliyn John. Each speaker urged those in attendance to vote early. In his remarks, Mark Romanchuk spoke about how his father didn't attend college, but his will to succeed brought the company to where it is today. He remarked how Richland County relies heavily on manufacturing, health care and leisure. Obhof noted that when the approval of the U.S.-Mexico-Canada Agreement was held up from replacing the North American Free Trade Agreement by opposing sides, Ohio lost thousands of jobs at the General Motors Lordstown plant and Ontario/Mansfield plant. He said it was a great day for Ohio when the deal was signed. Obhof said it will help put America first and create hundreds of jobs across the United States.

HEAP Summer Crisis Program runs until Sept. 30

Ohio Development Services Agency and the Ohio District 5 Area Agency on Aging will help income-eligible Ohioans maintain their utility service through the HEAP- Home Energy Assistance Summer Crisis Program.

The program helps eligible Ohioans pay an electric bill, purchase an air conditioning unit or fan, or pay for central air conditioning repairs. This year, the program runs until Sept. 30.

The program assists low-income households with an older household member (60 years or older), or households that can provide physician documentation that cooling assistance is needed for a household member's health. Examples of conditions can include lung disease, Chronic

Obstructive Pulmonary Disease, asthma and the like.

This year, households that were diagnosed with COVID-19 in 2020, have a disconnect notice, have been shut off, or are trying to establish new service on their electric bill are also eligible for assistance.

Scrapbook containing 17 years of memories donated to Ontario

Wyona Copeland, the wife of Roger Copeland, Ontario's first and winningest football coach, archived every year of her husband's football career at Ontario High School by collecting over 900 newspaper clippings and pasting them into three large scrapbooks.

On Aug. 18, Coach Copeland, now 92, donated her scrapbooks to the Ontario High School Athletic Department in a brief ceremony at Copeland Field.

"These historical newspaper clippings document 17 years of Ontario football," says Jeff Fisher, Ontario's athletic director. "They have found a home here and will be on permanent display in the Ontario High School trophy case."

In 2018 Coach Copeland's former players honored Coach's work as Ontario's first football coach by mounting a granite plaque at the entrance to Copeland Field.

"The three scrapbooks were reorganized

into one large scrapbook and professionally bound with a new cover," continued Fisher. "Each of the original pages were scanned, cropped, and organized into a CD or flash drive for people to view individually if they wished."

An email and direct mail campaign notified Coach Copeland's 200 plus former players of the scrapbook collection. Anyone interested in seeing a preview of the clippings or purchasing a CD or flash drive are invited to learn more at Copelandscrapbook.wordpress.com

Fisher added, "Anyone who played for Coach between 1961 and 1977 is somehow in print in these 413 digital pages. It's quite a treasure trove."

Roger and Wyona Copeland were married 67 years. Wyona Copeland passed away in 2018.

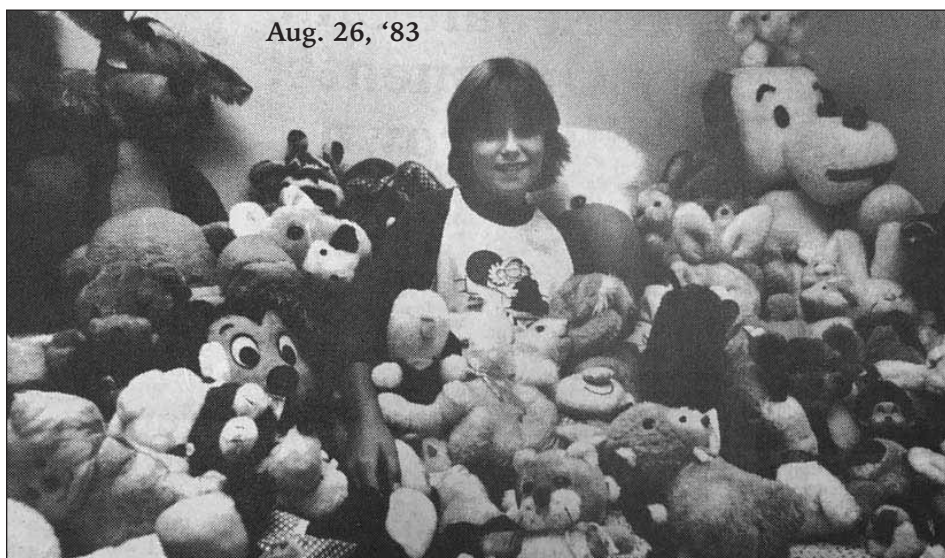

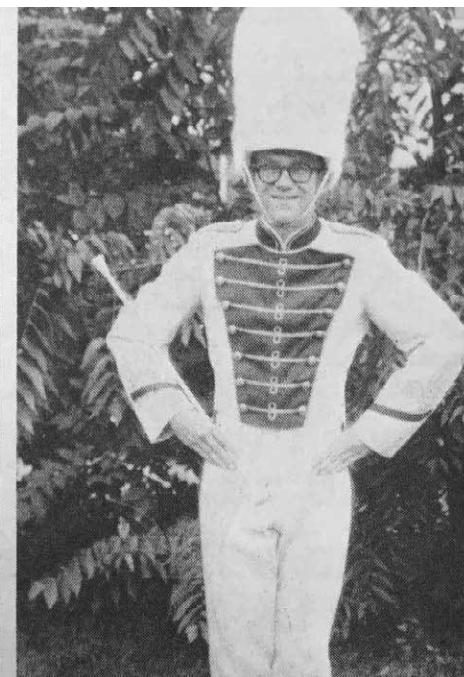
Lexington outscored its opponents by an average of seven runs a game while compiling an overall tournament record of 18-6.
