Lexington hires Anderson as officer

The Village of Lexington passed a resolution confirming the appointment of James Anderson as a full-time probationary police officer for the village and declaring an emergency. Anderson was employed upon the recommendation of the police chief.

The resolution is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of the village.

The resolution went into effect immediately to permit the police department to have an additional officer available as soon as possible.

The village also announced that councilwoman Erin Underwood gave her resignation, effective immediately.

Madison Board moves to make processes easier

The Madison Board of Education held a the operations of the school district, with virtual meeting on Wednesday, Jan. 6.

President Pro-Tem Tim Wigton called the meeting to order.

The board voted to authorize the superintendent to make offers of employment directly to candidates for either teaching or non-teaching positions on behalf of the board, and to acknowledge acceptance of such offers on behalf of the board. This is provided, however, that upon ratification of this board, the employment shall be deemed effective as of the date and time of the employee's acceptance of the superintendent's offer.

The superintendent will also be able to accept resignations which have been submitted by employees during times when the board is not in session, subject to ratification by the board. This is provided however, that upon ratification by the board, such resignations shall be deemed effective as of the date and time of the superintendent's acceptance.

The superintendent will be able to employ substitute and temporary (certified & non-certified) personnel (including Home Tutors) as needed for emergency situations. Such employment will be presented for approval by the board at its next meeting.

A Board Service Fund was established at \$20,000.

The superintendent has been authorized to apply for special grants and titles. He/She can also act as the purchasing agent for the district.

The board authorized the administration to apply for, receive funds for and participate in all Federal and State Programs as deemed necessary. Participation in the Federal Lunch and Breakfast programs for the calendar year 2021 was also approved.

The superintendent was given permission to attend all meetings necessary to expenses to be reimbursed.

The treasurer was also given authorization to attend all meetings necessary to the operations of the school district, expenses to be reimbursed.

The treasurer can also pay all bills as presented provided there are sufficient funds and purchase orders have been properly issued. A monthly report shall be presented to the board.

The treasurer an request advance tax money from the county auditor as funds are available and payable to the school district and can invest inactive funds and pro-rate interest to those accounts as deemed necessary by the treasurer.

The board president, treasurer and superintendent will be named as the district's record commission and the commission will meet 30 minutes prior to the August Regular Monthly Meeting.

The superintendent has been given

power to approve professional meeting attendance and expenses as deemed appropriate during 2021 in accordance with the negotiated agreement.

The board approved the firms of Renwick, Welsh & Burton; Pepple & Waggoner; Bricker & Eckler; and Tarkowsky & Piper Co., LPA for legal services on as needed basis for calendar year 2021.

The board agreed that the treasurer and executive secretary will attend Public Records Training in place of newly elected board members.

The board also designated The News Journal as the official paper of notification for the school.

The superintendent was designated as the Sexual Harassment Grievance Officer.

The meeting compensation will be continued at \$125, as previously approved.

Ma Rainey's Black Bottom is an adaptation of a 1982 Broadway play by August Wilson who also wrote *Fences*. Premiering

on Netflix, this movie surrounds a group of jazz musicians who are set to record an album on a sweltering hot day in Chicago in 1927.

Ma Rainey (Viola Davis), a popular jazz singer, has her band go to a studio to record an album. As the band assembles the young, ambitious trumpet player Levee (the late Chadwick Boseman) has other plans for what he wants to do and as tensions flare between him and the remainder of the group, personal stories emerge and decisions are made about where their futures lie.

As Levee, Chadwick Boseman gives the performance of his career and it is even more tragic because of this that we lost him so soon. Boseman transforms into Levee and has a couple long speeches that just bring the viewer in and doesn't let go until he is done.

Boseman deserves an Oscar nomination and, depending on who ends up being nominated, may be the first posthumous acting winner since Heath Ledger. He absolutely deserves it. What a range he had from *Black Panther* to playing James Brown in *Get On Up* to Jackie Robinson in 42.

Viola Davis has become one of the best actresses of her generation, winning an Oscar for *Fences* a few years ago, and nails her performance as Ma. She commands the screen and her makeup and costumes really elevate everything she brings to the role and she is perfectly cast.

Ma Rainey's Black Bottom does feel like a play as it is a story that is pretty much set in one setting. That might take away a little bit from it being an engaging movie as it doesn't move around like

most films but that is a small complaint. This is an engaging story, has some humorous movies mixed with the serious ones and brings out amazing work from Viola Davis and especially the very missed Chadwick Boseman.

Lexington's old, new school buildings

Having outgrown the 1850 school on Church St., voters in Lexington approved the construction of a new six-room school building in 1894. Part of it is still in use today after 126 years. The "Old Red Brick," as it is commonly known, solved the overcrowding of the former school. With six good size classrooms it was a very safe building with a fire escape for each classroom. There had been disasterous school fires around the country.

The big bell in the tower called all classes at starting time and again after lunch. For its time, the old girl was a beautiful statement for a progressive town even if it isn't by today's standards. There were no restrooms or running water.

If you had to "go" you had to go out the back door and up the hill to the large out-

house. There was one side for boys and one side for girls. A well pump furnished water until Lexington developed a water system in the late 1920s.

The coming need of high school classes pushed the old girl to the limits and frugal school leaders built a long prefabricated frame building on the north side lot.

When the state mandated the move to consolidated schools it ended the area's one-room school houses. Buses began transporting students to Lexington which resulted in the 1930 construction of a new high school building. The yellow brick was a much needed expansion for higher education and is the present day junior high building.

And now Lexington is having to build again. Will it ever end? Not as long as more kids need to learn. That's why Lexington is very proud of its good school system.

Foundation scholarships available

Whether the dream is to become a welder, graphic designer, health care worker or teacher, the Richland County Foundation has a variety of scholarship opportunities available for local students.

Graduating high school seniors and current college students from Richland County are eligible to apply for college and career technical education scholarships.

New applicants including high school seniors must have at least a 2.5 grade point average (GPA), and returning applicants must have at least a 2.0 GPA, attend an accredited school and be a resident or high school graduate of Richland County. The deadline for college scholarship applications is April 1.

The Foundation Board of Trustees also awards career technical education (CTE) scholarships to individuals who want to obtain certifications and credentials at accredited technical institutions. The applications will be considered as they are received, and the award determinations will be made within eight weeks.

The scholarship will be sent directly to the school. These are not recurring scholarships so students must re-apply each year. College and CTE scholarships are based on financial need.

SearchOhio is now fine free with a \$25 charge for lost or damaged materials.

Fines for damaged or unreturned MRCPL items will still be charged. Library cards will be blocked until the replacement fee(s) have been paid. Library cards will be charged for the full price of the item if not returned within 21 days of the due date.





Meatballs with sauce are \$6.99 per half dozen and \$10.99 per dozen.




