## The Case of the 1959 Murder

In June of 1959, a terrible tragedy struck Lexington. Chester Chalfant ran a Gulf gas station at the top of Delaware St. The building was torn down when the present car wash was built.

On that warm June day, H.D. Penelton stopped at Chalfant's station and the two were watching a ball game on TV. An argument erupted over a bet on the ballgame and Penelton shot Chalfant twice in the head.

Penelton was later arrested in Mansfield driving a stolen car and police found the gun used in the murder inside the glove compartment. Penelton had just been paroled after three years in the Ohio State Reformatory. He had only been free for three weeks when he murdered Chalfant.

Chester, paralyzed, was in the hospital and could only respond to questions by blinking his eyes. Shown a picture of Penelton and the gun, he became excited and the murderer ended up confessing to the murder on the same day as his death.

Penelton was sentenced to die in the electric chair and Ohio Governor Michael V. DiSallie visited him in prison and decided not to commute his sentence. On March 17, 1961, H.D. Penelton was the last person in the State of Ohio to die in the electric chair. Little satisfaction was felt by the Chalfant family.

Chalfant had been planning to retire and move to Florida with his wife. Ruth Chalfant was to be seen daily walking from her red brick home on E. Main St. to the Lexington Cemetery where her husband was buried. It appeared to cemetery workers she was talking or perhaps offering a prayer for her beloved Chester. She did this daily for nearly 30 years until she finally joined her husband in February of 1992

A multiple Oscar nominee this year is The Father. Now available on VOD and in select theaters this is the story of an

elderly man named Anthony as he deals with the effects of suffering from dementia and his daughter Anne (Olivia Colman) trying to help him through this terrible illness.

Anthony Hopkins plays Anthony and, usually with someone like Hopkins who has such an expansive history of terrific performances it would be suspicious to say that The Father is one of the best performances of his career, but that truly is the case. Hopkins is just brilliant

in the movie. He runs the gamut of emotions, sometimes all in one short scene. To see someone like Hopkins who has played such iconic roles and made such iconic films to be giving us one of the best performances of his career in his 80s is simply awesome.

Colman also does very fine work as his daughter Anne. She hits all the right points and we completely believe she wants the best for her father. The movie is directed by first time director Florian Zeller who adapted this movie from his own French stage play in 2012. Zeller cowriter the script with Christopher Hampton who also helmed a film like 1988's Dangerous Liaisons.

The entire structure of the story is so unique and may be one of the best films ever made about dementia. The story is

from Anthony's point of view, leaving the



viewer confused and unsure about what is happening, but that is the point. Much of this is due to how well the



movie is edited which has to be one of its best qualities for this story to work.

The movie also gets very emotional at times, especially near the end, and while the film may be described as depressing it's a movie that I personally will tell everyone to watch and few films are able to do that. Even though this movie is based on a play, it translates very well to film.

Hopkins beautiful, heartbreaking performance is the

centerpiece of this movie and it's a shame there is such competition in the best actor Oscar category this year because he should be a shoo in for his second Oscar.

The Father is a wonderful movie about a terrible disease that affects too many people and Hopkins gives one of the top 3 performances of his career and along with Colman's wonderful supporting work and Zeller's top notch story telling, The Father has my highest recommendation and is an excellent movie about a difficult subject matter.

## Legislation on county flexibility and energy cost-savings passes Ohio House

State Representative Marilyn John's (R-Richland County) legislation allowing more flexibility for counties and assisting them against rising energy costs passed unanimously in the Ohio House. John spoke to the bipartisan bill on the House floor.

"It establishes an exemption for utility supply contracts entered into under a joint purchasing program," said John. "Currently, county utility supply contracts are limited to 10 years. This legislation would exempt contracts from the 10 year limit. Additionally, this limitation does not apply to the state, municipalities, and townships; it only applies to counties."

John noted that these agreements will allow counties to lock in a portion of their energy loads for county facilities and aggregation programs. Moreover, the legislation could serve as a long-term constraint against rising energy costs and can produce savings for both counties and customers alike.

Before being passed this week, House Bill 87 had three hearings and passed unanimously in the Ohio House State and Local Government Committee: one of the

supporters of the bill that gave testimony on it included the County Commissioners Association of Ohio.

Along with John, State Rep. Jason Stephens (R-Kitts Hill) serves as a joint sponsor of the bill in addition to nearly 30 other cosponsors. The legislation now heads to the Senate for further consideration.


## Clear Fork FFA Alumni Tree Seedling Sale scheduled for next weekend

This spring, the Red Cross is teaming up with INDYCAR® to urge people to help keep the blood supply on track by donating blood or platelets. Schedule a donation appointment by downloading the Red Cross Blood Donor App, visiting Red-CrossBlood.org, calling 1-800-RED CROSS (1-800-733-2767) or enabling the Blood Donor Skill on any Alexa Echo device.

As a special thank-you, those who come to give blood or platelets April 1–15 will automatically be entered to win a VIP trip for four to the 2022 Indianapolis 500<sup>®</sup>. The Red Cross will also automatically enter all who come to give in April for a chance to win one of five \$1,000 e-gift cards to a merchant of choice.

The Red Cross is testing blood, platelet and plasma donations for COVID-19 antibodies. The test may indicate if the donor's immune system has produced antibodies, regardless of whether they developed symptoms.

Testing may also identify the presence of antibodies developed after receiving a COVID-19 vaccine. Convalescent plasma is a type of blood product collected from COVID-19 survivors who have antibodies that may help patients who are actively fighting the virus. Plasma from whole blood donations that test positive for high levels of antibodies may be used to help patients.

Donors can expect to receive the results of their antibody test within two weeks through the Red Cross Blood Donor App or the donor portal at RedCrossBlood.org. The Red Cross is not testing donors to diagnose illness. It is important that individuals who do not feel well or believe they may be ill with COVID-19 postpone donation.

Donors are asked to schedule an appointment prior to arriving at the drive and are required to wear a face covering or mask while at the drive.





The location will be accepting prescription pills of any kind, over-thecounter medications, medication samples, pet medications and vitamins. Please remove all prescription labeling before arriving.

Items not collected include needles, syringes, lancets, thermometers, aerosol cans, IV bags, hydrogen peroxide, bloody or infections waste, empty containers and personal products such as nonmedicated shampoo. No personal information will be collected. Paulette Hankins, party secretary, nominated local attorney Jonathon "JC" Elgin for the post. No other nominations were made and Elgin was appointed by unanimous consent.

The nomination now gets forwarded to Ohio Secretary of State Frank LaRose who will formally appoint Elgin to the board. Elgin will fill the unexpired term ending Feb. 28, 2025. Elgin previously served as a civil attorney for Richland County before entering private practice.

"I am humbled and honored to serve the voters of Richland County. Joe Mudra was committed to fair, free, and democratic elections I will do my best to follow in his gigantic footsteps," said Elgin. "Richland County is where I grew up and intend to remain. I am looking forward to joining my fellow board members in ensuring elections integrity here in our county."

The Richland County Board of Elections is a bipartisan board that supervises the conduct of every election taking place in the county. Members are appointed to four-year terms by the Secretary of State upon the recommendation of each political party's executive committees. Elgin joins fellow Democrat Lydia J. Reid and Republicans Bill Freytag and Megan Whatman serving Richland County in this capacity.

The deadline to register to vote or change an address and/or name in the voter registration system for the May 4, 2021 Primary/Special Election is Monday, April 5. The Board of Elections office will be open that evening until 9 pm.

The office is located at 1495 W. Longview Ave. Suite 101 in the Longview Center. After 4 pm, visitors must use the entrance at the lower level back parking area at the southwest corner of the building.

Voters must be either a native U. S. citizen, or a naturalized citizen of the U.S., a resident of Richland County and Ohio 30 days prior to an election and a minimum of 18 years of age by the date of the General Election on or before Nov. 2.

Registered voters who have moved or changed their name must notify the board office in writing or in person. Voters who are currently registered in Ohio may change their address at https://www.ohiosos.gov/elections/voters/, but must do it by the April 5 deadline. ## Protecting Ohio students from hazing

This month, another Ohio family is grieving. Stone Foltz, a 20-year-old sophomore at Bowling Green State University, died after alleged alcohol-induced hazing at a fraternity event.

Hazing isn't a "rite of passage," it's not just fun and games, and it's not something everyone does in school. It's dangerous, and it threatens the health and safety of Ohio students.

For every tragic death that we hear about in the news, there are many others who survive, but end up in the hospital with alcohol poisoning or other injuries – some of which can be long-term.

That's why I reintroduced the bipartisan REACH Act, to crack down on hazing on college campuses. It would require hazing incidents to be reported as part of a college's annual crime report. We can't begin to address this problem until we have good data on how many students are getting hurt, and we need to arm parents and students with more information.

The bill would also set a universal standard definition of hazing, and would require colleges to establish a campus-wide educational program, backed by evidence, to educate students about the dangers and lasting impacts of hazing.

We have to do more to stop these student deaths. Parents shouldn't have to worry for their child's safety just because they join a fraternity, sorority, or student organization on campus.

Hazing is a serious issue that we have the ability to combat, and we must work to stop more Ohio families from suffering the kind of pain the Foltz family is enduring.

Registration forms may also be obtained at vote.richlandcountyoh.gov or requested by mail. Call 419-774-5530 to have a form sent by mail. Completed voter registration forms must be postmarked 30 days prior to Election Day.

Not all precincts within Richland County will be open for the May 4 Election. All precincts in the City of Mansfield will be open and those voters can request a Republican or Issues Only ballot. All four precincts in the City of Ontario will be open with only the Charter Formation Issue on their ballot. No City of Shelby precincts will be open.

No polling places have been changed permanently, however, the board did approve a temporary change for the 15 voters in the Jeff-A precinct split who reside in the Washington Township portion, and the 200 voters in the Lex-B Washington Township split. These voters will be notified to go to Resurrection Parish, 2600 Lexington Ave. for this election only, in order to save funds by not opening a separate polling place for those few voters.
